Debt Securities Risk	The prices of, and the income generated by, bonds and other debt securities may be affected by changing interest rates and by changes in the effective maturities and credit ratings of these securities. Debt securities (including Municipal Bonds) may be affected significantly by the economic, regulatory or political developments affecting the ability of issuers to pay interest or repay principal. The value, interest rates, and liquidity of non-cash paying instruments, such as zero coupon and pay-in-kind securities, are subject to greater fluctuation than other types of securities.
10. 27. Management Risk

28. Market Risk

Markets are volatile and can decline significantly in response to issuer, market, economic, industry, political, regulatory, geopolitical, public health events, and other conditions. Portfolio shares at any point in time may be worth less than what you invested.

29. Merger Arbitrage Securities & Distressed Companies Risk

A merger or restructuring, or a tender or exchange offer, proposed or pending at the time the portfolio invests in merger arbitrage securities may not be completed on the terms or within the time frame contemplated, which may result in losses. Debt obligations of distressed companies typically are unrated, lower-rated, in default or close to default, and are generally more likely to become worthless than the securities of more financially stable companies.

31.	Mortgage & Asset-Backed Securities Risk	Mortgage-backed and asset-backed securities are subject to changes in the payment patterns of borrowers of the underlying debt. When interest rates fall, borrowers are more likely to refinance or prepay their debt before its stated maturity (Prepayment Risk). This may result in the portfolio having to reinvest the proceeds in lower yielding securities, effectively reducing the portfolio's income.
