## Securing your legacy

**Legacy Master®** from Western-Southern Life Assurance Company (Western & Southern Life) is a single premium whole life insurance policy that combines tax-deferred living benefits with the generally income tax-free death benefit of a life insurance policy.

With this policy, you make one lump-sum payment, referred to as a single premium. Then, you simply let your cash value grow.

#### Tax Benefits

- › Cash value accumulates income tax-deferred.
- › Life insurance proceeds pass to your beneficiary generally income tax-free. If properly planned, these proceeds may not be subject to estate taxes.

- › The policy's death benefit has the potential to increase in future years.

#### Guarantees

- › The death benefit is guaranteed for the life of the insured unless canceled by cash surrender or exhausted by loan.<sup>1</sup>

- › Death benefits may be paid without going through probate, bypassing hassles and delays.

In order for policies funded by an exchange to be issued as a non-MEC, the entire single premium must be in the form of a 1035 Exchange, and the existing policy must not be a MEC.
